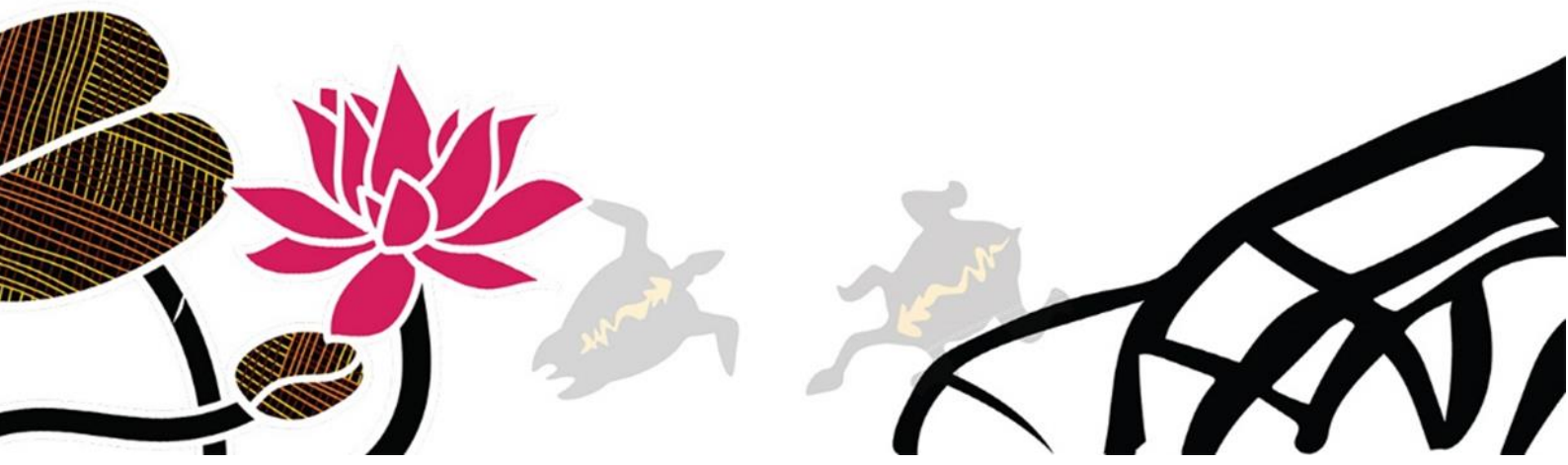

SUMMARY

This report is to provide the Maningrida Local Authority an update regarding the commencement of the community animal management program for Maningrida

BACKGROUND

MAN124/2021 Resolved that the Local Authority allocates \$27,930 from future Local Authority funding to the Animal Management Program

The Animal management program covered in the funding will undertake de sexing, tick treatment, euthanasia, flea treatment, and minor surgery as required across seven community visits.

COMMENT

The administration will prepare request for tender documents for the delivery of the specific animal management program as outlined in the Local Authority reports for each of the communities.

The administration is anticipating to complete the tender documents and have them released by the end of the next week.

STATUTORY ENVIRONMENT

No by-laws currently exist relating to animal management in WARC'S remote communities

WARC currently supports a limited program of animal management in Gunbalanya and Maningrida

SUMMARY

The purpose of this report is to provide the Maningrida Local Authority a cost breakdown for the supply and installation of bus stops signs in the community

BACKGROUND

In 2019/20, Bawinanga (BAC) successfully secured operational funding to support a bus service's operating costs through the NT Government Remote Passenger Transport Program. BAC purchased the bus with support from Child and Family Centre Grant.

BAC have expressed an interest to provide a permanent community bus service for Maningrida.

The bus service will run through the residential areas to deliver passengers to the commercial centre, supermarkets, workplaces, the art centre and the airport.

The proposed bus stop routes were provided by BAC during the last LA meeting

COMMENT

The bus stop signs are made from a 1.6 mtr long x 75mm square pole, yellow powder coated finish with the wording 'BUS STOP' printed and will be concreted into the ground. Please see attachment for reference.

The administration has estimated a cost for the supply and installation of EACH bus stop sign, which includes labour, materials and plant, to be \$530.00

COST BREAKDOWN FOR THE SUPPLY AND INSTALLATION OF EACH BUS STOP SIGN

ITEMS	AMOUNT incl gst
Supply of bus stop signs	\$185
Excavate footing	\$135
Placement of concrete	\$120
Install bus stop sign	\$90
Total	\$530

The actual final supply and install amount will be calculated by the number of approved bus stop locations. Further, there is a freight charge to Maningrida, which is estimated at \$750, dependent on quantity. Once finalised, there is a lead time of four (4) weeks from the date of approved purchase order.

This signage quantity and positioning will be determined during the current LA meeting as BAC is addressing the members to determine preferred locations. The administration will then proceed with this decided outcome.

BACKGROUND

MANLA/77 2019The Council received a grant funding to the value of \$1million from the NT Government and the Maningrida Local Authority committed \$600k consolidated total project funds to a value of \$1.6M towards Stage 1 of the upgrade and redevelopment of the Maningrida Football Oval on Lot 479.

COMMENT

Since last report, the contractor has completed the following:

- Chainmesh fence installation
- Finalised Goal post survey
- Goal posts delivered to site
- Light towers delivered to site

Still outstanding

- Footing light tower design to be completed within 2 weeks
- Commence construction of the light towers early September. Expected completion end of September
